

Written Statement from KATHY SHELTON read out at THE ALL AMERICAN RALLY FOR TRUMP held near the Liberty Bell in Philadelphia on October 16, 2016

When I was just 12 years old Hillary Clinton *personally* destroyed my life. She said I “deserved it.” And years later when she was asked about it, she laughed at how she had pulled it off.

At the age of 12, I was brutally raped and beaten on the side of a road in Arkansas. Left for dead by a 41-year-old child predator, I remained in a coma for five days. When I awoke, I found out that the man who did this to me had been caught, but I had no idea that my nightmare was just beginning.

You see, the man who raped and beat me was represented by a young and ambitious Hillary Rodham Clinton.
